

VICE-CHANCELLOR'S MANDARIN SCHOLARSHIP 2020: TERMS AND CONDITIONS

This scholarship award will cover your return flights, visa costs, tuition fees and accommodation fees for the Beijing Language and Culture University Summer School.

YOU ARE REMINDED THAT AS THIS IS AN ACADEMIC PROGRAMME ATTENDANCE IS REQUIRED AT ALL SESSIONS AND ALL WORK MUST BE COMPLETED AND SUBMITTED AS REQUIRED.

Application Details

Eligibility criteria: In order to be considered for this scholarship a student must be:

- A fully-enrolled student at NTU in the 2019/20 academic year; and
- Available to attend the whole of the summer school in August 2020; and
- Must have at least 6 months of validity on their passport from July 2020; and
- Must NOT be an incoming / visiting Exchange Student; and
- Must NOT be a final year Undergraduate student.

The NTU Global Office will consider all applications fairly and consistently. **The decision of the NTU Global Office is final and there is no opportunity to appeal against this decision.**

How to apply: Application is via the official online VC's Mandarin Scholarship Form which is available on Mobility Online. See our website for the link.

Application deadlines: The application process closes on Sunday 8th March 2020.

Notification process: You will receive email notification of the outcome of your application within 15 working days of the deadline. If successful you will be required to attend an interview on **Friday 20th March 2020**. You will be notified of the outcome of the interview within 5 working days.

Award requirements

1. **Pre-Departure Meeting** you will be required to attend a compulsory pre-departure meeting on **Wednesday 3rd June 2020** on the City Campus – the location will be confirmed nearer the time.
2. **You are required to submit an account of your international experience to the NTU Global Office 3 months from the return date of travel as indicated in your application form.** Students are encouraged to be creative with their submissions and use any format you wish e.g. written submission with photographs, video journal, PowerPoint presentation, poster, digital media such as blog link, YouTube link etc.). These submissions will be used for promotion of the scholarship and display by the NTU Global Office.

Additional information

Return flights will be booked by NTU Global and your visas will be processed by NTU's travel agent, Diversity. Please note that you will have to attend the visa centre in London for your Biometrics – NTU Global will organise this.

If, in the reasonable opinion of NTU, you have failed to provide us with all relevant information or have supplied false or misleading information relating to your application, we shall be entitled to seek full reimbursement from you - the Student Code of Behaviour may be invoked, and disciplinary action may be taken against you.
